1. 2. The setbacks, driveways, entrance gates, exists, staircases, corridors, and escape ways should not be changed, obstructed or modified in any way.
3. The occupier(s) shall train all staff and occupants periodically to make them well conversant in use and operation of the fire prevention and safety measures.
4. Fire Drills / rehearsals should be organized at least once in six months by involving local fire station.
5. Photocopies of this Certificate should be framed and displayed at all conspicuous places in all lobbies/corridors in all floors of all towers / blocks of building/ premises.
